NOTICE IS HEREBY GIVEN by the Colorado Housing and Finance Authority (the "**Authority**") that effective November 10, 2009, Citigroup Global Markets Inc. ("**Citigroup**") is removed as Remarketing Agent for the Authority's Multi-Family/Project Bonds, 2000 Series B-3 (the "**MF/PB 2000B-3 Bonds**") and Barclays Capital is removed as Remarketing Agent for the other Bonds, and the respective entities identified on **Exhibit A** attached hereto are appointed as successor Remarketing Agents for the respective Series of Bonds identified on **Exhibit A** attached hereto. Each such appointment with respect to any particular Series of Bonds has been approved by the applicable Liquidity Facility Provider for such Series of Bonds.

Barclays Capital is being removed as Remarketing Agent only with respect to the Series of Bonds identified on Exhibit A hereto (other than the Authority's MF/PB 2000B-3 Bonds, with respect to which Citigroup is being removed as Remarketing Agent), which does not necessarily include all of the Authority's Single Family Mortgage Bonds or Multi-Family/Project Bonds for which any particular institution acts as Liquidity Facility Provider.
