1. A Certified Check, Cashier's Check, or Money Order made payable to the Colorado Housing and Finance Authority for the re-issuance fee in an amount of \$500 (five hundred dollars); and
2. A copy of the payoff statement detailing the principal balance (NOTE: You may obtain a copy from your original Lender); and
3. A copy of the HUD-1 Settlement Statement for the new re-financed loan, signed by me (NOTE: You may obtain a copy from your Lender); and
4. A copy of the Mortgage Promissory Note (with all Riders, Addenda, or Modifications, if any) for the original loan, signed by me; and
5. A copy of the Mortgage Promissory Note (with all Riders, Addenda, or Modifications, if any) for the new refinanced loan, signed by me (NOTE: You may obtain a copy from your new Lender); and
6. The original, or if lost, a copy of the Mortgage Credit Certificate originally issued to me (NOTE: If you have previously had your certificate reissued, you should also include the RMCC).
7. If the original borrowers changed, a copy of the Decree of Divorce or Death Certificate.

AFFIDAVIT

The undersigned, as an essential part of the application for the Reissued Mortgage Credit Certificate, hereby swears (or affirms) that:

1. The property described in the address above is the same one for which I was originally issued a Mortgage Credit Certificate ("MCC") and is my principal residence.
2. The Mortgage Credit Certificate has not been revoked.
3. Except only for reason of death or divorce, I am the same person to whom the original MCC was issued.
4. I have refinanced my mortgage one or more times and am requesting that my MCC be reissued for my new mortgage indebtedness.
5. I will not use both the original and reissued MCC. I will use only the Certified Indebtedness Amount on the reissued certificate and not the principal balance of my new mortgage when calculating my annual tax credit.
6. I was not restricted as to which lender I used to refinance my mortgage loan and this lender did not provide a personal loan to me.
7. No part of the funding for the refinancing is from qualified mortgage bonds or qualified veterans' mortgage bonds.

I fully understand that each of the above statements is material to obtaining an MCC, and declare under penalty of perjury, which is a felony offense, that the above statements are true and correct.
